MINUTES OF BOARD MEETING
December 17, 2024

1. President Monte Garrett called the meeting of the West Cumberland Utility District Board of Commissioners meeting to order at 6 PM. 2. Visitors present were Reni Riden.

3. Ms. Riden asked why Brad Brown presented the board with a copy of the City of Crossville and Crab Orchard UD's rates, and he stated it was something to look at for future budgeting purposes.

5d. There was 1 leak repair between October 16, 2024 and November 15, 2024.

Melissa presented the board with an offer that was received from Uplands Retirement Village to obtain a CDBG grant from the Town of Pleasant Hill to purchase their sewer treatment plant.

MOTION: 12/17/24-03 Wayne Blankenship moved, seconded by Darrell Moore, to not accept the offer from Uplands RV to purchase their sewer treatment plant. All voted aye. Motion carried.

6a. **MOTION: 12/17/24-04** Jesse Iles moved, seconded by Brad Brown, to keep officers the same until after the next commissioner election. All voted aye. Motion carried.

7. Adjournment.

MOTION: 12/17/24-05 Jesse Iles moved, seconded by Darrell Moore, that the meeting be adjourned. All voted aye. Motion was carried.

President Garrett adjourned the meeting at 6:50 pm.


